BRPC Participates in Annual Warrenton Area Chamber of Commerce Economic Development Luncheon

Boonslick Regional Planning Commission participated in the annual Warrenton Area Chamber of Commerce Economic Development Luncheon on Tuesday, January 13th. Interim Director Chuck Eichmeyer presented information about area population trends, housing starts, unemployment numbers and educational attainment. Looking at the data and the changes that have occurred over time in the region enables planners, local government officials and businesses to prepare for needs that may arise according to what the trends show.

Greater Warren County Economic Development Council President Gary Carter shared how the group formed and began working with Josh Beck and Steve Etcher from Community EDGE, LLC. Steve Etcher then explained some of the criteria businesses look at when selecting a site and Josh Beck discussed their efforts to attract new business to the area while helping existing business grow and prosper.

During discussion on the importance of having a well-trained workforce, Eichmeyer mentioned the Missouri Career Center. Partnering with the Warrenton Area Chamber of Commerce, Career Center Director JoAnn Toerper and staff are assisting Warren County in its efforts to become a Certified Work Ready Community.
