## City of Hawk Point Water Improvement Project



Work is progressing on the City of Hawk Point's water improvement project. A new 100,000 gallon elevated water storage tank has been constructed which will enable the city to meet the daily demands of the community without having water shortages. It will also enable the city to meet Missouri Department of Natural Resources regulations. The photos above show the progression as work is being done on the tower which still needs to be painted inside and out.

Although the city has done a quality job of maintaining its water system, the distribution lines varied in age and condition. Undersized and deteriorated lines in the oldest part of the community are being replaced. Nearly 15,000 lineal feet of water distribution lines will be replaced. Additional lines are being constructed to connect the new system to the current system.

Boonslick Regional Planning Commission worked with the City of Hawk Point to obtain funding through the Community Development Block Grant Program in the amount of \$499,250 for this project. Additional funding came from USDA Rural Development with a grant of \$495,000 and a loan of \$1,155,000.

This water improvement project will greatly enhance the water quality and availability for the community of Hawk Point. A growing number of cities may face needed improvements to their water and wastewater systems due to age and changes in regulations. If you anticipate that your community might be in such a position, please contact BRPC so that staff might begin the process of helping you meet those infrastructure needs.

## Mobility Coordinator Hired

Boonslick Regional Planning Commission is pleased to announce that Deana Dothage has been hired as a Mobility Coordinator. The Mobility Coordinator will serve a five county region which includes Franklin, Lincoln, Montgomery, St. Charles and Warren.

In this position, Dothage will work to identify and remove transportation barriers for people in the region—especially senior citizens, and individuals with disabilities or with low-to-moderate incomes. Under the direction of the BRPC Executive Director, Dothage will coordinate efforts to enhance the availability and access to transportation services by establishing and operating a one-call center.

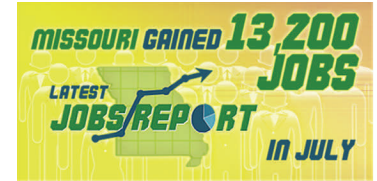

## Montgomery County Hazard Mitigation Plan Meeting

The Montgomery County Emergency Management Agency, in association with Boonslick Regional Planning Commission, is beginning the process of updating the county's Natural Hazard Mitigation Plan. The purpose of the plan is to reduce or eliminate long term risk to the people and property of the county from the effects of natural hazard events. This approach will ensure that the county's local governments remain eligible for all possible disaster recovery assistance.

A Hazard Mitigation Planning Committee kick-off meeting will be held at the Montgomery County Ambulance Station, 603 Stoddard Memorial Drive, New Florence; at 6:30pm on September 16<sup>th</sup>. All incorporated municipalities and school districts within the county must participate in the planning process and legally adopt the updated plan. The general public is invited as well.
