Regional Project Brings \$7.5 Million Workforce Training Center

Additional training opportunities are going to be available for residents in the region. In a collaborative effort, Lincoln County, the Lincoln County R-III School District, the State of Missouri, and Boonslick Regional Planning Commission worked with Ranken Technical College to establish a campus in Troy, Missouri. A groundbreaking ceremony was held in June, with hopes that the facility will be ready for students in the fall of 2021.

Ranken plans to offer secondary and post-secondary education and training, initially focusing on advanced manufacturing, building and construction trades, and aquaponics. Several options will be available for students who can earn professional certifications, associate degrees, or a bachelor of science degree in applied management—depending on their choices and career goals.

The United States Department of Commerce Economic

Development Administration (EDA) awarded grant funds in the amount of \$5.1 million for the nearly 25,000 sq. ft. facility. The EDA funding will be matched with \$360,000 in local investment, and \$1 million in funding from the State of Missouri. The project is expected to create nearly 100 jobs and generate \$2.8 million in private investment.

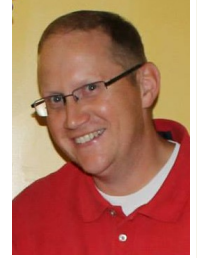
The new training facility will provide valuable skills for both future and present workforce participants, increasing their employment opportunities. The training that will be offered will help address workforce needs of employers throughout the region.

MoDOT Buckle Up Phone Down Safety Initiative Receives NADO Award



The National Association of Development Organizations (NADO) has given the Missouri Department of Transportation (MoDOT) Buckle Up Phone Down initiative an Excellence in Regional Transportation Award. The award recognizes noteworthy projects and practices that help meet regional needs through various program areas, including safety.

Boonslick Regional Planning Commission Planner Krishna Kunapareddy nominated the Buckle Up Phone Down effort for the NADO award, stating: "Missouri's Buckle Up Phone Down Program is helping to save lives at the local level by raising awareness for the dangers associated with distracted driving and not wearing a seat belt. This two-part message has been well received throughout the state and is now gaining attention at the national level as a viable, life-saving strategy."

This recognition helps support MoDOT's emphasis to renew a focus on safety as a national public health issue, and to begin tackling it by taking Missouri's successful Buckle Up Phone Down safety initiative to the national level. As a result, three other states – Wisconsin, Nebraska and Kentucky – are actively promoting the movement, while 11 states have expressed interest in taking up the cause and spreading the safety message.

To help continue the initiative's national momentum, MoDOT has created a Buckle Up Phone Down Starter Kit. It provides the tools necessary for entities interested in implementing the life-saving venture, including a video outlining the history of the program. MoDOT implemented the Buckle Up Phone Down program in 2017 as a way to combat a growing number of fatalities on state roadways and to promote two of the most effective actions drivers can take to stay safe when getting behind the wheel – fastening their seatbelts and putting down their cell phones. BRPC Executive Director Chad Eggen said, "We hope this generates some movement on the initiative. It is terrific to see impact from such small changes to personal behaviors."
