City of Old Monroe Levee Project is Complete

During flooding of December 2015 - January 2016, the levee on the Cuivre River in the City of Old Monroe was damaged and the area declared a Federal Disaster under declaration DR-4250. Excessive flows from the flooding damaged the levee streambank and public road on top of it. If not repaired, the citizens would face future threats of flood waters destroying houses, separating people from access to emergency services, and destruction of public streets and property.

The City received funding from Natural Resources Conservation Service (NRCS) to help in addressing this important need, but lacked the additional amount necessary for local match and payment for other flood repairs. Boonslick Regional Planning Commission (BRPC) assisted the city by writing an emergency grant to secure funds through the Community Development Block Grant (CDBG) program. CDBG funding served as the local match, enabling the City of Old Monroe to utilize NRCS funding to complete the project. BRPC served as administrator, and Program Coordinator Chuck Eichmeyer as inspector for the project which was completed in September of this year.

Montgomery County Celebrates Certified Work Ready Designation


Supporters of Montgomery County's effort to attain designation as a Certified Work Ready Community (CWRC) gathered to celebrate the achievement of this goal on Thursday, September 27, 2018.

Montgomery County Presiding Commissioner Ryan Poston welcomed everyone. He explained that 228 individuals in the county had attained a National Career Readiness Certificate, showing they had skills needed by employers. Mardy Leathers, Director of the Division of Workforce Development – Missouri Department of Economic Development, served as guest speaker for the event. He shared his excitement that all three counties in the Boonslick Region have achieved the CWRC designation, and presented Montgomery County officials with a proclamation from the Governor's office.

Job Center Hosts Successful Hiring Events

Boonslick Regional Planning Commission has been a busy place! The Job Center hosted a hiring event for Schnucks September 26–28. The



company has constructed a new 37,000 square foot grocery store on Veterans

Memorial Parkway in Warrenton, just west of Highway 47. The store will open on November 7 of this year and bring 60 new jobs to the area.

The event was very successful, with individuals attending for on-the-spot interviews. Representatives from Schnucks indicated they were very pleased with the turnout and services provided by staff, and asked to return on October 3 and 4. In total, 300 people attended the two hiring events.

Thus far, forty-five people have been hired for a variety of positions. Several other individuals have been scheduled for additional interviews with Schnucks.

Job center staff provided assistance with creating flyers, marketing the hiring events throughout the region, and posting the open positions on jobs.mo.gov, Staff were on hand to greet job seekers, help them register, and fill out online applications. They also assisted the team from Schnucks with the flow of customers waiting for interviews.



Conflict Resolution

Dr. Pamela Moehl served as the guest presenter at a Community Agency Partnership meeting held at BRPC on September 19, 2018. Dr. Moehl, who is a specialist in organizational development and training, spoke about conflict resolution.

Each of us develop behavior patterns which tend to come out when conflicts arise. Some behaviors, such as allowing issues to build up over time, blaming others, or lashing out in anger, promote conflict escalation. To prevent this from happening, it is important to communicate.

Dr. Pamela Moehl Dr. Moehl discussed the advantages

and risks of several ways individuals respond to conflict. She stressed that people can improve their communication skills and shared that being able to respect yourself and other people is the foundation of integrity.
