Temco Project Completed

Temco, Inc., established in 1971, is an extended employment facility-based sheltered workshop. The not-for-profit organization is located in Marthasville and employs adults with developmental disabilities. Temco provides custom packaging, assembly and order fulfillment services throughout east central Missouri and the greater St. Louis area.



Temco staff contacted BRPC for assistance. They wanted to pursue opportunities that would make it possible for them to build an addition which could be used as a work area. The extra space would allow the present work area to be converted to a break room that would accommodate all employees. Improvements were also needed for existing restrooms to make them ADA compliant.

Warren County agreed to sponsor a Community Development Block Grant application for the needed improvements at Temco. BRPC wrote and submitted a Community Facilities grant application which was selected for funding. The project allowed for the construction of a 1,900 sq. ft. addition which addressed the organization's needs. Restrooms were updated with necessary improvements. Funding was available for additional work to be done which enabled Temco to have its own water and wastewater systems.
