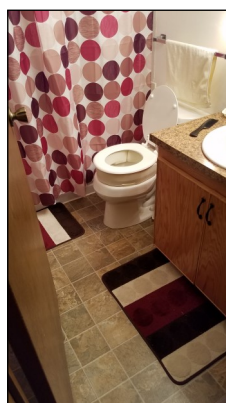
## Wells Villa, Inc. Receives Grant Funding in the Amount of \$990,000 for Rehabilitation Project in the City of Wellsville



Wells Villa is a 33 unit senior housing complex located in the City of Wellsville. Constructed in 1972, the units were financed through USDA Rural Housing Services. The board of Wells Villa continues to follow the guidelines first established through the USDA program, with the facility serving low income elderly and disabled persons.

Although Wells Villa has an excellent record of unit maintenance, the board does not typically have the funds for capital improvements necessary to boost the structural integrity and functionality of the units. Boonslick Regional Planning Commission (BRPC) worked with board members and submitted an application requesting funding to address needed structural, mechanical, and service upgrades. Planned upgrades included replacing existing shingle roofs with metal roofs, repairing existing porches, replacing siding, replacing doors and windows, renovating bathrooms with ADA-compliant tubs and toilets, rehabbing kitchens, removing and replacing uneven sidewalks, and installing new concrete on existing gravel parking lots.

Wells Villa, Inc. has been awarded \$990,000 in grant funding through the Federal Home Loan Bank Affordable Housing Program. Boonslick Regional Planning Commission will serve as project manager and provide inspection services. ## Job Fair in Lincoln County



The Missouri Job Center—Warrenton, in collaboration with Veterans' Services and Lincoln County Economic Development, held a job fair on Thursday, February 13, 2020. The event took place at the Lincoln County Health Department in Troy, with twelve employers participating.

In an effort to reach individuals who might benefit from having the event take place later in the day, organizers set the time of the job fair from 3:00 p.m. to 6:00 p.m. Thirty five job seekers were in attendance.

With low unemployment, many employers are struggling to find workers who are qualified for their businesses. Job seekers who participated in the event were pleased to leave with several prospects for employment.

Boonslick Regional Planning Commission staff members provide the workforce programs for the Job Center. There are programs for youth and adults, and a variety of services available, including free workshops and assistance with creating a resume and searching for jobs. The staff also assists employers in meeting their hiring needs.

## Fingerprinting Services Available at BRPC

As a reminder, Boonslick Regional Planning Commission has contracted with Idemia to assist with background checks through the Missouri Highway Patrol. BRPC can assist with fingerprinting for employment, record checks, or background screenings.

# IdentoGO®

School districts now require parents and grandparents who would like to assist in classrooms or accompany students on field trips to have a background check, including fingerprinting. Staff has seen an increase in traffic due to this requirement, and in 2019, served 3,268 customers.

Many individuals who assumed they might have to drive to the St. Charles or St. Louis areas have expressed appreciation that BRPC offers the fingerprinting services. Those who need the background check must first go to the IdentoGO website and register. Before doing so, they will need to have a 4 digit code from the entity that is requiring the background check. After registering, customers can put in the zip code for Warrenton and they will be able to pick a date and time that works with their schedule to come in for service. Although BRPC accepts walk-in customers, it is important to keep in mind that those who choose this option will have to wait if other customers have scheduled a specific appointment time.
