This section presents the mitigation strategy updated by the Lincoln County Mitigation Planning Committee (MPC) based on the updated risk assessment. The mitigation strategy was developed through a collaborative group process. The process included review of the general goal statements to guide the jurisdictions in lessening disaster impacts as well as specific mitigation actions to directly reduce vulnerability to hazards and losses. The following definitions are taken from FEMA’s Local Hazard Mitigation Review Guide (October 1, 2012).

- **Mitigation Goals** are general guidelines that explain what you want to achieve. Goals are long-term policy statements and global visions that support the mitigation strategy. The goals address the risk of hazards identified in the plan.
- **Mitigation Actions** are specific actions, projects, activities, or processes taken to reduce or eliminate long-term risk to people and property from hazards and their impacts. Implementing mitigation actions helps achieve the plan’s mission and goals.

4.1 Goals

This planning effort is an update to Montgomery County’s existing hazard mitigation plan approved by FEMA in 2016. Therefore, the goals from the 2016 Warren County Hazard Mitigation Plan were reviewed to see if they were still valid, feasible, practical, and applicable to the defined hazard impacts.

The MPC conducted a discussion session during their second meeting to review and update the plan goals. To ensure that the goals developed for this update were comprehensive and supported State goals, the 2018 State Hazard Mitigation Plan goals were reviewed. The MPC also reviewed the goals from recently updated Missouri county plans. It was determined that the broadly stated goals were still valid for the 2021 update.

- Goal 1; Protect the lives and livelihoods of all citizens
- Goal 2; Employ sustainable principles and practices to enhance mitigation effectiveness
- Goal 3; Ensure continued operation of government and emergency functions during a disaster.

4.2 Identification and Analysis of Mitigation Actions

At the initial clerk meetings, specific hazards to each jurisdiction were discussed along with several ideas on existing and new action plans. During the meeting of the MPC, the results of the risk assessment conducted by the Warren County EMD and Boonslick RPC staff were presented for review and the key issues were identified for specific hazards and discussed. The discussion included possible new mitigation actions, as well as actions from the previously approved plan. Actions from the previous plan included completed actions, on-going actions, and actions upon which progress had not been made. Changes in the risk since the adoption of the previously approved plan were discussed as well. The MPC discussed SEMA's identified funding priorities and the types of mitigation actions generally accepted by FEMA.

The meeting focused on updating the mitigation strategy. For a comprehensive range of mitigation actions to consider, the MPC reviewed the following information during the meeting.

- A list of all actions proposed in the previous mitigation plan, the current State plan, and recently approved plans from nearby counties
- Key issues from the risk assessments, including the problem statements that conclude each hazard profile and vulnerability analysis
- State priorities established for Hazard Mitigation Assistance grants
- Public input during the meetings, responses from Data Collection Questionnaires, and other efforts to involve the public in the plan development process.
- Data Collection Questionnaires were sent to each jurisdiction prior to the kick-off meeting followed with several phone calls explaining what is expected. The kick-off meeting allowed the respondents to ask follow-up questions about the questionnaires. The Data Collection Questionnaires are part of Appendix.

At the meeting, MPC members were updated with each community's risk assessment and also provided information on how additional mitigation planning instructions could be obtained. After the meeting, the list of actions for each jurisdiction were emailed to the MPC. Each jurisdiction was instructed to provide information regarding the Action Status.

The MPC included problem statements in the plan update at the end of each hazard profile. The problem statements summarized the risk to the planning area presented by each hazard and include possible methods to reduce that risk. Use of the problem statements allowed the MPC to recognize new and innovative strategies for mitigate risks in the planning area.

During review at the meeting, it was determined that many actions have been completed to the extent reasonable, that some actions were no longer practical or otherwise attainable, and that the remainder remained viable and should be continued. Based on the status reviews, there are 1 to 9 completed actions depending on the jurisdictions, 8 to 32 deleted actions, and 1 to 6 continuing

actions depending on the jurisdictions. The table below summarizes action plan status for each jurisdiction.

4.3 Implementation of Mitigation Actions

Jurisdictional MPC members were encouraged to meet with others in their community to finalize the actions to be submitted for the updated mitigation strategy. Throughout the MPC consideration and discussion, emphasis was placed on the importance of a benefit-cost analysis in determining project priority. The Disaster Mitigation Act requires benefit-cost review as the primary method by which mitigation projects should be prioritized. The MPC decided to pursue implementation according to when and where damage occurs, available funding, political will, jurisdictional priority, and priorities identified in the 2018 Missouri State Hazard Mitigation Plan. The benefit/cost review at the planning stage primarily consisted of a qualitative analysis and was not the detailed process required for grant funding application. For each action, the plan sets forth a narrative describing the types of benefits that could be realized from action implementation. The cost was estimated as closely as possible, with further refinement to be supplied as project development occurs.

The plan indicates if the prioritization process and / or methodology have changed since the previous plan's adoption. If the process changed, the change is described along with the how and why it changed. If the prioritization process and methodology did not change, it is so noted. Actions were prioritized independently for EACH jurisdiction. For example, if two communities each had an action to acquire floodprone properties, these were evaluated independently based on each jurisdiction's capabilities.

FEMA's STAPLEE methodology was used to assess the costs and benefits, overall feasibility of mitigation actions, and other issues impacting project. During the prioritization process, the jurisdictions used worksheets to assign scores. The worksheets posed questions based on the STAPLEE elements as well as the potential mitigation effectiveness of each action. Scores were based on the responses to the questions as follows:

Definitely YES = 3 points
Maybe YES = 2 points
Probably NO = 1 points
Definitely NO = 0 points

The following questions were asked for each proposed action.

S: Is the action socially acceptable?
T: Is the action technically feasible and potentially successful?
A: Does the jurisdiction have the administrative capability to successfully implement this action?
P: Is the action politically acceptable?
L: Does the jurisdiction have the legal authority to implement the action?
E: Is the action economically beneficial?
E: Will the project have an environmental impact that is either beneficial or neutral? (score "3" if positive and "2" if neutral)

Will the implemented action result in lives saved?
Will the implanted action result in a reduction of disaster damage?

The final scores are listed below in the analysis of each action. The worksheets are attached to this plan as Appendix B. The STAPLEE final score for each action, absent other considerations, such as a localized need for a project, determined the priority. Low priority action items were

those that had a total score of between 0 and 24. Medium priority actions were those scoring between 25 and 29. High priority actions scored 30 or above.

No new action items are added to Goal 3. All the action items included in 2016 plan are determined as an ongoing activity or already accomplished. However, the committee decided to keep Goal 3 for future plan purposes.
